Kendall Jones

Kendall was a social worker and the finest advocate a child in need could hope for. Her secret weapon was a deck of Skip-O cards or a Tigger doll to break down the wall of resistance in frightened kids.

We spent most Thanksgivings together with Kendall and her mother Kathy Kidd. During our visits, I could count on Kendall telling us about her and Bell's adventures on the trail, always exclaiming how brave Bell was. Her dream was to have me show Bell at Live Oak CDE someday.

Kendall will be remembered with a smile on her face when she had the reins in her hands driving that big old Clydesdale named Bell.

JOB DESCRIPTIONS

BOARD MEMBERS:

PRESIDENT

The President shall preside at all meetings and over the Board, and have the duties normally assigned to such office and as outlined in the By-Laws or designated by the Board of Directors.

VICE PRESIDENT

The Vice President (or appointed representative) shall attend all planning meetings, shall have the powers and exercise the duties of the President in case of the President's absence incapacity or death. The VP shall also serve as coordinator of the Club's statewide drives, and is in charge of the calendar.

SECRETARY

The Secretary oversees the legal affairs of the Club, sends out notices of meetings, keeps records of meetings, minutes, record of attendees, motions, etc. Secretary will also maintain the List of Policies adopted by the Club and maintain insurance.

TREASURER

The Treasurer is responsible for the financial affairs of the Club. Establishes bank accounts, deposits funds, disburses funds, maintain the books and financial activity, which books are open for review by the Board and the Audit Committee. Treasurer undertakes the legal reporting and is authorized to employ legal and auditing expertise. Treasurer provides a financial report to the membership at the Annual Meeting.

MEMBERSHIP CHAIRMAN

The Membership Chair maintains the list of members, takes applications, maintains the applications and release forms, sends out dues notices and provides mailing lists. Membership Chair also works with newsletter editor and secretary to ensure that all members receive notices, ballots, newletters, etc., as required.

REGIONAL DIRECTORS:

Regional Directors shall be responsible for calling an annual planning meeting and hold the biannual election of the regional director. They shall also be responsible for planning their calendar and report on those activities. Regional Directors or alternates shall attend all functions and meetings in their region.

Alternates shall attend events and meetings in the absence of the Regional and have voting powers when the Director is not in attendance. The Alternate shall also keep the minutes of the regional meetings.

I am glad that I had my coach with me, Sterling Graburn. He was great in keeping me grounded and focused on the tasks ahead of me. Even with him - the first time driving under the arch and into the stadium to perform my dressage test, well, it was awe inspiring. Nothing like seeing your name on the jumbotron representing your country!

The marathon portion was next. I was excited to do "the Gulch". I had heard so much about it. That would change for me - disappointment. As a para-driver I would only be doing six of the hazards and "the Gulch" was the one eliminated for me. It was ok and I focused on learning the paths through my hazards. It was different in that gates were eliminated and replaced with other gates - meaning that I might do A through E, but in the next hazard I might do A, B, D, E, F - it was new to me, but my coach was right there to help me through it. On marathon day, first hazard was a little rough, but after that it was smooth! I ended up having 5 of the 6 hazards faster than my able bodied intermediate drivers! Super proud of my driving!

Cones course would end my experience at Live Oak International 2020. The cones course was challenging in a new way. Not only did you have to go fast and go clean through the course, but added to the challenge was driving around the jumps! I had no time penalties and only had one ball down. I had a great run and a great time!

Live Oak International 2020 was a great experience and lots of fun!

Fun in the Sun (FITS)

On March 15th, the first FITS Endurance Festival Competitive Drive was held at the farm of Valerie Kanavy close to the Black Prong Equestrian Village. Following 3 days of endurance riding activity, the organizers and volunteers stayed the extra day to introduce Competitive [distance] Driving to the North Central Florida region. Using the rules of SEDRA (South Eastern Distance Riders Association) (https://www.distanceriding.org/wp-content/uploads/2020/01/SEDRARuleBook010220.pdf), there was a learning curve for everyone to accomplish either the introductory 12.5 mile or the sanctioned 25 mile drive.

I am so in tune with driving measured kilometers, counting gates upward, and generally ADS rules that some SEDRA requirements and the approach to distance driving took me by surprise. Notes to abide by for next year:

*There is no distinction for times between pony/horse or single/multiples.

*Kicking straps are required (thank you Robin and Wilson Groves for having one to lend)

*Distances are measured in miles and count down. For the 12.5 mile drive, there were markers at 10, 5 and 1 mile.

*Watering stations were plentiful. However, a horse that is trained to not drop his head [to eat grass] while in harness might also take exception to reaching down into the barrel troughs.

*One must trot in the last 1/4 mile

*At finish, 10 minutes to unharnessed and water horse to bring back for 20min hold and inspection. Can splash on water, but no hosing, alcohol or other cooling agents

- *The 25 mile drivers are encouraged to feed grains at their interim hold
- *There are 2 vets scoring and checking horses before and after the drive
- *Your horse must trot in hand for vet inspections. (Sheridan had no issue in the morning trot, but my volunteer handler didn't ask the opinionated Morgan 'his way' to trot in afternoon so we lost some points there.)

The FITS crew did an outstanding job of laying out tracks that were carriage friendly and not chewed up with deep sand, until that last 1/2 mile leading back to the finish line. THAT was a bit tough especially since my marathon carriage is still waiting for pneumatic wheels to use for Florida conditions.

The FITS sponsors were also extremely generous and I came home with a new muck bucket from Black Prong Equestrian Village, a full sized container of electrolytes from Mad Barn, and the FITS T-shirt.

With a total of 9 turnouts, singles and pairs, ponies and horses, drivers were fairly represented. I look forward to doing the drive again next year, maybe with a lighter weight cart, and improving our condition score. Assuming another success, it might be worthwhile for the Florida Whips to team up with SEDRA and pursue more opportunities for holding competitive [distance] drives throughout the various regions.

Tips and Guidelines for showing in a Pleasure Driving Show

"The ephemeral satisfaction and constant concentration that a perfect turnout can provoke is practically a "joy forever" and certainly a rare experience....and a thrilling one." Quote from Crafty, Paris 1890 as translated by Sue de Brantes:

You've entered your very first Pleasure Show. Perhaps you have watched a few and have a general idea of how it works, or, you've taken a few lessons and have decided that you'd like to give this "show" thing a try, but not sure of exactly what is expected.

The American Driving Society dedicates about 48 pages in their rule book to the specificity

of Pleasure Driving Shows. However, in the case of a Pleasure "FUN" Show, the organizers along with the judges, can tone down the rules and make provisions for a variety of carriage types and turnouts.

A Fun Show is really a learning opportunity and a place to ask questions. Our judging team for the PBCMP thought it would be beneficial for newcomers to know in advance what is going to be required. In the case of the Pleasure (Junior/Beginner and Open) Classes it states that the class will be "judged 50% on the Horse and 50% on the Driver". What does that mean exactly?

Let's start with the Horse. 25% of the score would judge the animal. Is he well groomed, mane braided, hooves oiled, tail combed and shiny? A judge would look at the overall horse's performance, his soundness and gaits, especially transitions to each command and the horse's compatibility to the carriage. 25% to be judged on the carriage and harness which should be clean to the point of pleasing to the eye and color coordinated. The bit correct as to functioning for the horse, blinkers properly positioned. It is also the opportunity to present whatever type carriage you have to its best potential.

Those are a lot of variables to go into 50%, but here's the thing...it's the overall picture. You may have a beautiful carriage, but if it's not clean and your high stepping horse's mane is long and unkempt, the overall picture may not be as lovely as the driver with a training cart and a steady pony that is clipped and braided.

Now onto the Driver, also 50%. The key is not to compete for attention or to overwhelm your horse and carriage. Complement your carriage. That means, a clean and tidy outfit, colors to work with your animal and carriage rather than being loud and garish. A driver's standard for most shows includes brown smart fitting gloves, apron, which length should be mid-calf to above ankle when sitting and blend with the color of the jacket. It is customary for ladies and gentlemen to wear a hat practical to weather or time of day and most definitely helmets are acceptable and not discounted, as well as being required for junior drivers. This "turnout" score would account for 25% of the Driver score.

The other 25% is about showing your skills without difficulty and with preparedness being evident in the driver's ability to put his or her pony through its required paces seemingly without effort. For a Fun Show, working trot, slow trot and a walk in both directions, a halt and perhaps a few steps of backing, would be asked. A whip is required with the length point to reach either side of the horse just behind the saddle with appropriate length lash. Correct use of whip, posture of driver, use of hands, actual contact to horse's mouth, and subtle yet clear transition signals, score higher marks.

Without being stuffy or ridged, the very phrase "Pleasure Show" is a specific driving competition, which owns some history, tradition, and perhaps a bit of pomp. While our junior drivers would have been exempt from aprons and jackets for this event, it is the duty of our Whips judges and organizers to provide the necessary building blocks should some of our participants wish to advance to more formal show competitions. The same basic turnout should be considered for the cones classes and the reinsmanship classes. We carry the torch and hope to lead our newcomers to a "joy forever".
